

# NOMINATION FOR SCISDA HALL OF FAME



The first Hall of Fame Inductees were presented at the 25<sup>th</sup> SCISDA Annual Square & Round Dance Convention in July 2008 and the tradition continues each year. This is a very prestigious award given to a person or couple who has been an active part of square dancing and has unselfishly volunteered their time and talents to the benefit and promotion of square dancing statewide. The fact that one is nominated is in itself a very high honor whether or not they enter the Hall of Fame.

Candidates may be a dancer, caller or cuer. They should have approximately 10 years statewide involvement with SCISDA and should be known fairly well throughout the State of Illinois not only in their own Club or Affiliate organization. A candidate does not need to be a current member of a club and may be nominated by any square dancer, caller, cuer, club or affiliate. There are no limits or restrictions to the number of nominees approved each year.

Nomination forms should be sent to the SCISDA Corresponding Secretary for forwarding to the Committee no later than April 1<sup>st</sup> of the year for which the award is to be considered.
